## The population of the world (2003)

Every other year, the summer issue of *Population and Societies* presents a global picture of the world population. The data shown here can be found in the *World Population Data Sheet* published by the Population Reference Bureau (PRB) [1]. Each year, this independent organization provides synthetic data sheets using figures obtained from different sources, mainly the United Nations Population Division [2], the United States Census Bureau, the Council of Europe and... INED [3], which endeavours to assemble all the demographic data published by national statistics agencies and international organizations.

### ◆ The indicators and their quality

The data shown in the central data sheet concern all geopolitical entities with a population of 150,000 or more and a few others. Sovereign states are listed along with non-sovereign territories, among which France's overseas departments. Countries and territorial entities are listed following the United Nations' system of classification per region and continent.

The demographic indicators are for the most part the same as those used in earlier editions: land area, mid-2003 population estimate, birth and death rates, population projection for 2025, infant mortality rate, total fertility rate, percentage of population under 15 and over 65, male and female life expectancy at birth, Gross National Income per capita adjusted for purchasing power parity (GNI PPP) in 2001, proportion of persons with HIV/AIDS among the adult population aged 15 to 49 at the end of 2001 (these figures include persons who are suffering from AIDS as well as those

who have been infected by the virus but are not yet ill). The last column provides an indicator of data availability, in four categories. The countries rated "A" are developed countries with complete vital statistics and regular census-taking or population registers. The total population of these countries is 980 million. The countries rated "B", which include five of the six most populous countries (China, India, Indonesia, Brazil, Pakistan) represent the largest share of the world population — 4.5 billion. Those rated "C", among which the most populated is Nigeria, represent about 554 million; those marked "D" are mostly countries where no census has been conducted following recent disruptions or conflicts (Afghanistan, Angola, Bosnia-Herzegovina, Congo, Myanmar, etc.), a population totalling 200 million.

Fifteen smaller tables classify countries or geopolitical entities according to several indicators, following a downwards scale. In the first eight tables, a world total is given and a line separates the countries totalling more than half of the world figure. For instance, the six most populated countries (the five mentioned above in addition to the United States) represent a total population of 3.2 billion, or more than half of the world population, estimated at 6.3 billion. ■

## Notes

• **World and regional totals.** Regional population totals are independently rounded and include small countries or areas not shown in the table. Regional and world rates and percentages are weighted averages of countries for which data are available; regional averages are shown when data are available for at least three quarters of the region's population.

• **The tables** taken from the *World Population Data Sheets* should **not be used as a time series**. Fluctuations in values from year to year often reflect revisions based on new data or estimates rather than actual changes in levels. Additional information on likely trends and consistent time series can be obtained by consulting publications of the organizations listed above.

• **Area.** This refers to the "land area" or "total area" of the country, excluding area under inland water bodies, i.e. major rivers

and lakes. Variations are due to updates and revised data provided by the countries and do not necessarily reflect an actual change in the country's area. The PRB used the data provided by the last *FAO Production Yearbook*.

• **Population mid-2003.** Estimates are based on a recent census, official national data, or UN and U.S. Census Bureau projections. The effects of refugee movements, large numbers of foreign workers and population shifts due to contemporary political events are taken into account to the extent possible. Such events can lead to a high degree of uncertainty in the estimates.

• **Data availability code.** The data availability code provides a general indication of data availability from "A" (complete) to "D" (few or no data).

An "A" indicates a country with both complete vital statistics (births and deaths) and either a national-level census within 10 years or a continuous population register.

If a country has complete vital statistics or a continuous population register and a national-level census within 15 years, it is rated "B". Also rated "B" are countries that have one of the three sources necessary for an "A" plus either a usable national survey or a sample registration system within 10 years.

"C" indicates that at least a census (within 15 years), a survey (within 10 years), or sample registration system is available.

"D" indicates that little or no reliable demographic information is available and that estimates are based on fragmentary data or demographic models.

There can be considerable variation in the quality of data within the same category.

• **GNI PPP.** This is Gross National Income converted to US dollars using a purchasing power parity (PPP) factor; this indicator is not available for all the countries.

### The European Union, from 15 to 25 member states

With the entry of ten new members – Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia – in 2004, the European Union will group 25 countries, two-thirds more than the present 15. What is the position of this enlarged EU in the world setting?

Although the demographic characteristics of the new member states differ from those of the EU-15 (see the central data sheet and the adjacent summary table), their population size will not substantially reshape the Union. With the exception of Poland – almost 40 million – all are small countries: the total population of the ten new members is only 75 million, a one-fifth increase to the present 380 million.

A total population of 450 million places the EU-25 far behind the two world heavyweights, China and India (over a billion each), but way ahead of the United States with its 290 million. In terms of annual number of births, the ten new members move the EU two steps up the world ladder: whereas the EU-15 lies just behind the US (respectively 4.0 and 4.1 million births), the EU-25 moves ahead of both the US and Bangladesh. However, it does not catch up with Pakistan, Nigeria or Indonesia, although all these countries are much smaller in size.

Owing to the higher mortality and lower fertility and income of the ten new member states, the EU loses one to three places in the tables relevant to these three criteria.

The most noteworthy change is in the rate of population growth (not shown in the central tables, see the adjacent summary table). From +3.6 per 1,000 population for the EU-15, the growth rate falls to +2.7 for the EU-25. The ten new members combined have a negative growth rate of -1.8 per 1,000 as a result of more deaths than births and more emigration than immigration.
