Development of data collection systems during the pandemic

In the Republic of Moldova, data on mortality throughout the pandemic were published by the Ministry of Health (MH). Statistics on the Republic of Moldova do not include Transnistria. The MH publishes only laboratory-confirmed COVID-19 deaths despite using the definition recommended by the WHO which includes suspected cases. Most of those deaths occurred in hospitals. Since 12/11/2021, the date of death also appears in the death records published by the MH.

Medical institutions report confirmed COVID-19 deaths to the National Agency for Public Health.

4.1. Age group: 0-4, 5-9, 10-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84, 85+

4.2. Sex: male and female, broken down by age group

4.3. Reference date type: date of report for data by age and sex in the Excel tab "MH_Deaths by age and sex" and for daily totals in the tab "MH_Daily total"; date of death for age and sex data in the "MH_AgeSex_DateOccurrence" tab and for daily totals in the "MH_Total_DateOccurrence" Excel tab.

4.4. Place of death: *Not applicable*

A.5. Update frequency and data cut-off time

The epidemiological situation report is published daily at 17:00.

Coverage

Data include deaths from Covid-19 infection occurred in hospitals or elsewhere during the last 24 hours by date of report, sex and age. The official statistics of the Republic of Moldova does not include death and population counts since 1997 for Transnistria region. Although data on deaths from COVID-19 infection for Transnistria are published by the MH, it is excluded from the database due to the absence of population counts by sex and age. On 23 December 2020, the total number of deaths from COVID-19 infection registered in Transnistria was 8% of the total of COVID-19 deaths registered in Moldova (227 out of 2825 deaths).

In November and December 2021, the National Agency for Public Health checked the completeness of the registration of deaths from COVID-19 in hospitals [5]. As a result, on 30 December 2021, 579 deaths were published as unreported by hospitals. For these deaths no information was provided [6].

Data collection method

The definition of death from COVID-19 approved by the MH of the Republic of Moldova [1] corresponds to the definition recommended by WHO. According to it, "a death due to COVID-19 is defined for surveillance purposes as a death resulting from a clinically compatible illness, in a suspected or confirmed COVID-19 case, unless there is a clear alternative cause of death that cannot be related to COVID disease (e.g., trauma). There should be no period of complete recovery from COVID-19 between illness and death" [2].

The MH approved the following ICD-10 codes to codify deaths from COVID-19 infection [3].

U07.1 – COVID-19, virus identified

U07.2 – COVID-19, virus unidentified

However, the MH publishes only the laboratory confirmed COVID-19 deaths. Medical institutions (hospitals if a patient with confirmed COVID-19 infection died in hospital or primary health care institutions if a patient with confirmed COVID-19 infection died at home) notify the National Agency for Public Health about the confirmed COVID-19 deaths [4].

Collected data

MH publishes daily death records notified to the National Agency for Public Health during the last 24 hours with the indication of the serial number of death (starting from death 42 on 15 April 2020), age in complete years, sex, region, name of the medical institution where the case of death was registered, date of hospitalization or transfer to another hospital and concomitant diseases. If a deceased person belonged to a medical personal, his/her name, age and the place of work are usually indicated. Since 11 November 2020, MH stopped publishing the date of hospitalization or transfer to another hospital.

On 23 December 2020, 98% of deaths from COVID-19 was registered as occurred in hospitals. Less than 1% of deaths was registered at home due to patient's refusal of hospitalization as indicated in daily MH report. Finally, the place of death is not indicated for 1% of deaths. Most of these deaths were registered before 15 April 2020, when the outline of the epidemiological situation report was not fixed and the medical institution where the

case of death occurred was not mentioned. For deaths registered in Transnistria, the place of death is not indicated. Since 12 November 2021, the MH started to include the date of occurrence in COVID-19 death records.

Periodicity and countdown stop time

Since 4 August 2020, the MH published the epidemiological situation report daily at 17.00 (the time of publication is not exact and may vary). Before that date, the MH published the epidemiological situation report twice per day. Since 30 January 2022, the MH publishes the reports notified to the National Agency for Public Health on the preceding day.

Further information

We have saved the daily epidemiological report issued by the MH as pdf file for each day when COVID-19 deaths were registered starting from March 18 2020. In the excel data file we provide links to the webpages where the report was published. Before August 4 2020, two epidemiological reports are presented for each day (see periodicity and countdown stop time). Death records may be included in the first or in the second or in both reports. For certain death records registered in April Facebook announcements issued by the MH are presented. The example of the daily epidemiological report issued by the MH on December 19 2020 is shown in Annex 1.
